

THE BOROUGH OF EASTLEIGH (CHANDLERS FORD AND HILTINGBURY)

NOTICE IS HEREBY GIVEN that the Eastleigh Borough Council pursuant to arrangements under Section 19 of the Local Government Act 2000 with Hampshire County Council has made the above mentioned Traffic Regulation Order in exercise of the powers of the said County Council under Sections 1, 2, 4, 32, 35 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers.

Any persons wishing to question the validity of the Order or any provisions contained in them on the grounds that any requirement of the Act, or any instrument made under it has not been complied with in relation to the Order, may within six weeks from (21 October 2016) apply to the High Court for this purpose.
