

## **EASTLEIGH BOROUGH COUNCIL**

### **Notice of a diversion order confirmed under section 257 and Schedule 14 of the Town and Country Planning Act 1990 (TCPA 1990)**

The Eastleigh Borough Council (Footpath Cycleway No. 23 Eastleigh and unnumbered presumed dedicated footpath cycleway) Diversion Order 2016 (“the Order”)

1. Eastleigh Borough Council (“the Council”) gives notice that it has confirmed the above Order without modification
  
2. The effect of the Order is to:
  - (a) stop up the unnumbered presumed dedicated footpath cycleway:
    - (i) From point B (SU44128 19446) on the attached plan (“the Plan”) south towards point C (SU44140 19424) for a distance of 28 metres then south towards and of 3 metres width;
    - (ii) From point D (SU44128 19390) south towards point E (SU44120 19305) for a distance of 56 metres and 3 metres width then east towards point F (SU44173 19307) for a distance of 62 metres and 3 metres width.
  - (b) stop up the footpath cycleway number Eastleigh 23 south of Leigh Road Eastleigh from point A (SU44148 19447) on the Plan south towards point C (SU44140 19424) for a distance of 24 metres then south towards point D (SU44128 19390) for a distance of 37 metres then south east towards point F (SU44173 19307) for a distance of 96 metres).
  - (c) create an alternative footpath cycleway south of Leigh Road Eastleigh from point A (SU44148 19447) on the Plan south towards point C (SU44140 19424) for a distance of 24 metres then south towards point D (SU44128 19390) for a distance of 37 metres then south east towards point F (SU44173 19307) for a distance of 96 metres.
  
3. A copy of the confirmed Order and Plan may be inspected free of charge at the Council Offices at Eastleigh House, Upper Market Street, Eastleigh, Hampshire, SO50 9YN between the hours of 09:00 and 17:00 Mondays to Fridays (excluding bank holidays and public holidays) from 2 December 2016 to 13 January 2017. 4. The Order comes into force on 2 December 2016.

5. Any person aggrieved by the Order and wishing to question its validity, or any provision contained in the Order, on the ground that it is not within the powers of the TCPA 1990 or that any procedural requirement of the TCPA 1990 or any regulation made under the TCPA 1990 has not been complied with in relation to the confirmation of the Order may within six weeks from 2 December 2016 apply to the High Court under section 287 of the TCPA 1990.
