

BOROUGH OF EASTLEIGH (BISHOPSTOKE, FAIR OAK AND HORTON HEATH) (AMENDMENT NO 2) ORDER 2019 PART 1

The Council of the Borough of Eastleigh (hereinafter referred to as "the Council") pursuant to arrangements made with the Hampshire County Council in exercise of the powers of the said County Council under Sections 1, 2 and 4 of the Road Traffic Regulation Act 1984 ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

Commencement and Citation

1. This Order shall come into operation on 24 June 2019 and may be cited as the "The Borough of Eastleigh (Bishopstoke, Fair Oak and Horton Heath) (Amendment No 2) Order 2019 Part 1."
2. The Borough of Eastleigh (Bishopstoke, Fair Oak and Horton Heath) (Amendment No 1) Order 2018 shall be revoked in its entirety
3. In this Order the Principal Order means The Borough of Eastleigh (Bishopstoke, Fair Oak and Horton Heath) Consolidation Order 2017 as amended

Prohibition and Restriction of Waiting

4. The contents of Schedule 1 shall be deleted from Schedule 1 to the Principal Order
5. The contents of Schedule 2 shall be added to Schedule 1 to the Principal Order
