

THE BOROUGH OF EASTLEIGH (HEDGE END, WEST END AND BOTLEY)

(AMENDMENT NO 6) ORDER 2019.

The Council of the Borough of Eastleigh (hereinafter referred to as "the Council") pursuant to arrangements made with the Hampshire County Council in exercise of the powers of the said County Council under Sections 1, 2 and 4 of the Road Traffic Regulation Act 1984 ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

Commencement and Citation

1. The Borough of Eastleigh (Hedge End, West End and Botley) (Amendment No 5) Order 2018 shall be revoked in its entirety
2. This Order shall come into operation on 1 July 2019 and may be cited as the "The Borough of Eastleigh (Hedge End, West End and Botley) (Amendment No 6) Order 2019."

Prohibition and Restriction of Waiting

3. In this Order the Principal Order means The Borough of Eastleigh (Hedge End West End and Botley) Consolidation Order 2015 as amended
4. The Principal Order is hereby amended as follows:
 - (a) In the first Schedule (No Waiting at Any Time) after item number 213 (relating to Itchen Valley Country Park access road) there shall be inserted:

213a. Ivy Lane Both From its junction with Swaythling Road south-westwards for a distance of 15 metres.

- (b) In the first Schedule (No Waiting at Any Time) items numbered 362 and 363 (relating to Rosemount Court) shall be deleted

- (c) In the first Schedule (No Waiting at Any Time) after item number 361 (relating to Repton Gardens) there shall be inserted:

362. Rosemount North- From its junction with Swaythling Road north-
 Court west eastwards for 5 metres.

363. Rosemount South- For its entire length
 Court west
