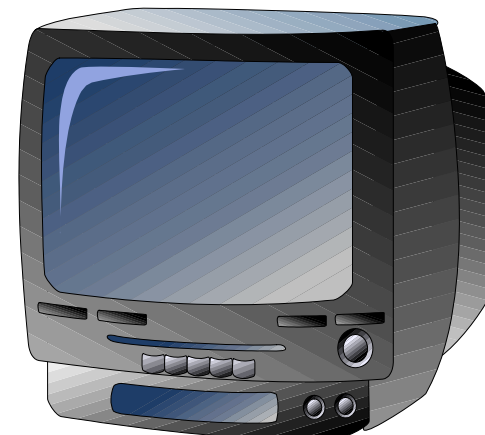

# Concession Scheme

If you are:

- Permanently housebound **AND**
  - The person responsible for payment of the TV Licence **AND**
  - Unable to use public transport **AND**
  - Under 75 years of age **AND**
  - Not living with someone who receives a concession towards a TV Licence **AND**
  - Unable to take advantage of the Council's Concessionary Fares Scheme because you are permanently housebound.
- you could be entitled to a

**HOUSEBOUND TELEVISION LICENCE CONCESSION**

Eastleigh Borough Council's TV Concession Scheme is designed to help permanently housebound residents who are unable to take advantage of the Concessionary Fares Scheme.

The scheme provides a TV Licence Concession which can be used in part-payment for a television licence.

If you think you qualify, simply complete and return the attached application form.

A visiting officer will then call round to see you and ask some further questions.

**DO YOU QUALIFY?**

To qualify for the scheme, you need to be:-

- a) under 75 years, not in receipt of a free TV Licence, **OR**
- b) aged over 16 years, not involved in full time education, **AND**
- c) confirmed as permanently housebound by your doctor or social worker, **AND**
- d) the person responsible for the payment of the TV Licence ie
- e) the owner of the property or the registered tenant liable for the rent **AND**
- f) not living with someone who receives a concession towards A TV Licence **AND**
- g) permanently resident within the Borough of Eastleigh

**ALL** the above conditions must apply for you to be eligible.

**ONLY ONE CONCESSION WILL BE ISSUED PER HOUSEHOLD.**

If an applicant has difficulty completing the form, a friend or relative may complete and sign on behalf of the applicant indicating who they are and their relationship to the applicant.
