

THE BOROUGH OF EASTLEIGH (BURSLEDON, HAMBLE-LE-RICE AND HOUND)
(AMENDMENT NO 11) ORDER 2021

The Council of the Borough of Eastleigh (hereinafter referred to as "the Council") pursuant to arrangements made with the Hampshire County Council in exercise of the powers of the said County Council under Sections 1, 2 and 4 of the Road Traffic Regulation Act 1984 ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

Commencement and Citation

1. This Order shall come into operation on 30 August 2021 and may be cited as the "The Borough of Eastleigh (Bursledon, Hamble-Le-Rice and Hound) (Amendment No 11) Order 2021."

Prohibition and Restriction of Waiting

2. In this Order the Principal Order means The Borough of Eastleigh (Bursledon, Hamble-Le-Rice and Hound) (Consolidation) Order 2012 as amended.
3. The following shall be added as a new Article 27c to the Principal Order:
 - (1) Save as provided in Articles 31 and 33 of this Order no person shall except upon the direction or with the permission of a Police Constable in uniform or a civil enforcement officer cause or permit any vehicle to wait between the hours of 8.00 am and 6.00 pm on any day other than a Sunday on the sides of road or in the lengths of road specified in the Twenty Eighth Schedule to this Order-
 - a) For a longer period than 2 hours; or
 - b) If a period of less than 2 hours has elapsed since the termination during the said hours of the last period of waiting (if any) of the vehicle in those lengths of roads.
4. The contents of Schedule 1 shall be inserted into the Fourth Schedule to the Principal Order.
5. The contents of Schedule 2 shall be deleted from the Fourth Schedule to the Principal Order.
6. The contents of Schedule 3 shall be inserted as a new Schedule 28 to the Principal Order.

Schedule 1 No waiting at any time (Addition)

	Road	Side	Description
1	Beach Lane	South	From its junction with Victoria Road for its entire length, including its closed end.
1j	Beach Lane	North	From its junction with Victoria Road in a South-westerly direction for a distance of 12 metres.
1k	Beach Lane	North	From a point 24 metres south of its junction with Victoria Road for 19 metres in a south-westerly direction
1l	Beach Lane	North	From its closed end in north-easterly direction to a point 110 metres south-west of its junction with Victoria Road.

Schedule 2 No waiting at any time (deletion)

	Road	Side	Description
1.	Beach Lane	South	For the whole of its length including the turning head.
4.	Beech Lane	Northwest	From its junction with Victoria Road in a southwesterly direction for a distance of 10 metres.

Schedule 3 Waiting limited to 2 hours, return prohibited within 2 hours, Mon-Sat 8am-6pm (addition)

	Road	Side	Description
1	Beach Lane	North	From a point 12 metres south of its junction with Victoria Road for 12 metres in a south-westerly direction.
2	Beach Lane	North	From a point 43 metres south of its junction with Victoria Road for 58 metres in a south-westerly direction.
