

THE BOROUGH OF EASTLEIGH (EASTLEIGH TOWN CENTRE) CONSOLIDATION ORDER 2022

NOTICE IS HEREBY GIVEN that Eastleigh Borough Council pursuant to arrangements under Section 119 of the Local Government Act 2000 with Hampshire County Council has made the above mentioned Traffic Regulation Order in exercise of the powers of the said County Council under Sections 1, 2, 4, 32, 35 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers.
