

**THE BOROUGH OF EASTLEIGH (CHANDLER'S FORD AND HILTINGBURY)**  
**(AMENDMENT NO 9) ORDER 2022**

The Council of the Borough of Eastleigh (hereinafter referred to as "the Council") pursuant to arrangements made with the Hampshire County Council in exercise of the powers of the said County Council under Sections 1, 2 and 4 of the Road Traffic Regulation Act 1984 ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

Commencement and Citation

1. This Order shall come into operation on 12 August 2022 and may be cited as the "The Borough of Eastleigh (Chandler's Ford and Hiltingbury) (Amendment No 9) Order 2022."

Prohibition and Restriction of Waiting

2. In this Order the Principal Order means The Borough of Eastleigh (Chandler's Ford and Hiltingbury) Consolidation Order 2016 as amended.
3. The contents of Schedule 1 of this Order shall be inserted into Schedule 1 of the Principal Order
4. The contents of Schedule 2 of this Order shall be deleted from Schedule 4 Part B of the Principal Order
5. The contents of Schedule 3 of this Order shall be added to Schedule 4 of the Principal Order

**Schedule 1 No waiting at any time (Addition) to Schedule 1 of the Principal Order**

Road	Side	Description
Ashdown Close	Both	From its junction with Ashdown Road south-westwards for 15 metres
Ashdown Road	South	From a point 15 metres west to a point 15 metres east of the junction with Ashdown Close
Kings Road	South	From the boundary of properties No 10 and 12 eastwards for a distance of 5.5 metres
Oakwood Road	Both	From its junction with Hiltingbury Road south-westwards for 15 metres
Hiltingbury Road	South	From a point 15 metres west to a point 15 metres east of the junction with Oakwood Road

**Schedule 2 shall be deleted from Schedule 4 Part B of the Principal Order**

Hut Farm Place	North Eastern	In the lay-by for its entire length.

**Schedule 3 Limited waiting (Addition) to Schedule 4 of the Principal Order**

Hut Farm Place	North-East	Introduce limited waiting (4 hours no return for 4 hours) in the layby outside properties No 62 and 63, for a distance of 10 metres
