

THE BOROUGH OF EASTLEIGH (CHANDLERS FORD AND HILTINGBURY)
(AMENDMENT NO.16) ORDER 2015

The Council of the Borough of Eastleigh (hereinafter referred to as "the Council") pursuant to arrangements made under Section 19 of the Local Government Act 2000 with the Hampshire County Council in exercise of the powers of the said County Council under Sections 1, 2, 4, 32, 35, 45 and 46 of the Road Traffic Regulation Act 1984 ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

Commencement and Citation

- 1. This Order shall come into operation on 11 January 2016 and may be cited as the "Borough of Eastleigh (Chandlers Ford and Hiltingbury) (Amendment No.16) Order 2015".

Prohibition and Restriction of Waiting

- 2. In this Order the Principal Order means The Borough of Eastleigh (Chandlers Ford and Hiltingbury) (Prohibition and Restriction Of Waiting) (Disabled Persons Parking Places) Order 2004
- 3. The Principal Order is hereby amended as follows:

(1) In Part III (Prohibition and Restriction of Waiting) after Article 20(e) there shall be inserted:

(f) Between the hours of 9am and 10am and between the hours of 2.30pm and 3.30pm on any day other than a Saturday or Sunday or Bank Holiday on the sides of roads or in the lengths of roads specified in the Eleventh Schedule to this Order.

(g) Between the hours of 8am and 5pm on any day other than a Saturday or Sunday on the sides of roads or in the lengths of roads specified in the Twelfth Schedule to this Order.

(2) In the First Schedule (No waiting at any time) before item number A (relating to Ashdown Road) the following shall be inserted:

i	Apollo Road	Both	From its junction with Peverells Wood Avenue in a south western direction for a distance of 19 metres.

- (5) In the First Schedule (No waiting at any time) after item number 17C (relating to Charnwood Crescent) the following shall be inserted:

17D	Charnwood Crescent	North	From a point 13 metres east of its junction with Charnwood Gardens to a point 11 metres west of that junction.

- (7) In the First Schedule (no waiting at any time) before item number 20A (relating to Forest Road) the following shall be inserted:

20.1	Ford Avenue	Both	From its junction with Shaftesbury Avenue in a southern direction for a distance of 19 metres.

- (8) In the First Schedule (No waiting at any time) item number 22 (relating to Hiltingbury Road) shall be revoked and replace with:

22	Hiltingbury Road	Northeast	From a point 110 metres northwest of its junction with Ashdown Road in a south eastern direction to a point 111 metres east of that junction.

(9) In the First Schedule (No waiting at any time) item number 22A (relating to Hiltingbury Road) shall be revoked and replaced with:

22A	Hiltingbury Road	South west	From a point 113 metres northwest of its junction with Ashdown Road in a south eastern direction for a distance of 199 metres.

22C	Hiltingbury Road	Southwest	From a point opposite a point 91 metres southeast of its junction with Ashdown Road in a south eastern direction for a distance of 82 metres.

22G	Hiltingbury Road	Northeast	From a point 19 metres northwest of its junction with Malibres Road in a south eastern direction for a distance of 58 metres.

(15) In the First Schedule (No waiting at any time) after item number 47 (relating to Peverells Wood Avenue) the following shall be inserted:

47a	Peverells Wood Avenue	Southwest	From a point 14 metres northwest of its junction with Vespasian Way in a south east direction to a point 13 metres south east of that junction.

47b	Peverells Wood Avenue	Northeast	From a point opposite a point 12 metres northwest of its junction with Vespasian Way in a south east direction to a point 14 metres south east of that junction.

50Bi	Ribble Close	Northeast	From its junction with Bodycoats Road in

50Bii Ribble Close Southwest From its junction with Bodycoats Road in a south eastern direction for a distance of 15 metres.

50Biii Ribble Close West Within Ribble Close (Spur), from its junction with Ribble Close in a northern direction for a distance of 14 metres.

(18) In the First Schedule (no waiting at any time) after item number 61 (relating to Shaftesbury Avenue) the following shall be inserted:

61i Shaftesbury Avenue Both From a point 17 metres northwest of its junction with Treloyhan Close in a south eastern direction to its junction with Ford Avenue and Skipton Road.

(19) In the First Schedule (no waiting at any time) after item number 61i (relating to Shaftesbury Avenue) the following shall be inserted:

61ii Skipton Road both From its junction with Shaftesbury Avenue in a north eastern direction for a distance of 17 metres.

61iii Skipton Road North west and north east From a point 12 metres southwest of its junction with Pennine Way in a north eastern and then south eastern direction for a distance of 59 metres.

61iv Skipton Road South east and south west From a point 12 metres southwest of its junction with Pennine Way in a north eastern and then south eastern direction for a distance of 48 metres.

(20) In the First Schedule (No waiting at any time) item number 64B (relating to Sutherlands Way) shall be revoked and replaced with:

64B Sutherlands Way Southwest and south From a point 30 metres east of its junction with Southdale Court in a north western direction for a distance of 115 metres.

(21) In the First Schedule (No waiting at any time) after item number 76A (relating to Trafalgar Close) the following shall be inserted:

76Ai Treloyhan Close Both From its junction with Shaftesbury Avenue in a northern direction for a distance of 18 metres.

(22) In the First Schedule (No waiting at any time) after item number 76C (relating to Valley Road) the following shall be inserted:

76Ci	Vespasian Way	Both	From its junction with Peverells Wood Avenue in a south westerly direction for a distance of 19 metres.

(23) In the Second Schedule (No Waiting Monday to Saturday 8am-6pm) item number 2 (relating to Purkess Close) shall be revoked.

(24) In the Third Schedule item numbers 4i and 4ii relating to Kingsway shall be revoked from the Third Schedule.

(25) After the Tenth Schedule the following shall be inserted:

No waiting Monday to Friday 9 - 10am and 2.30 - 3.30 pm, excluding bank holidays

1	Kingsway	Northwest	From a point 19 metres southwest of its junction with Hiltingbury Road in a south western direction for a distance of 35 metres.
2	Kingsway	Southeast	From a point 19 metres southwest of its junction with Hiltingbury Road in a south western direction for a distance of 26 metres.

(26) After the Eleventh Schedule the following shall be inserted:

TWELFTH SCHEDULE

No waiting Monday to Friday 8am – 5pm

1	Richmond Close	East and north	From a point 15 metres west of its junction with Ashdown Road in a western and then northern direction for a distance of 30 metres.
2	Richmond Close	South and west	From a point 15 metres west of its junction with Ashdown Road in a western and then northern direction for a distance of 44 metres (not including Richmond Close spur) to the southern boundary of 9 Richmond Close.

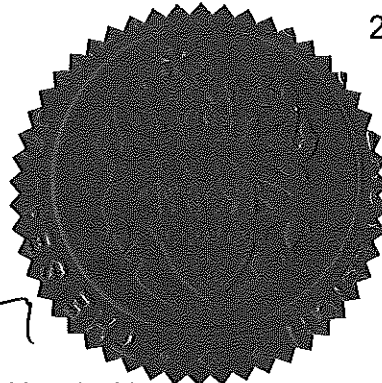
