

THE BOROUGH OF EASTLEIGH (CHANDLERS FORD AND HILTINGBURY)
(PROHIBITION AND RESTRICTION OF WAITING) (CONTROLLED ZONE) ORDER
2016

NOTICE IS HEREBY GIVEN that the Eastleigh Borough Council pursuant to arrangements under Section 19 of the Local Government Act 2000 with Hampshire County Council has made the above mentioned Order in exercise of the powers of the said County Council under Sections 1, 2 and 4 of the Road Traffic Regulation Act 1984 ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police.

The general effect of this order is to make The Borough of Eastleigh (Chandlers Ford and Hiltingbury)(Prohibition and Restriction of Waiting)(Controlled Zone) Order 2016, the effect of which would be to introduce waiting restrictions, as detailed below:

- a) 'No Waiting at Any Time' restrictions in the following roads:

Conway Close,	Donnington Drive,	Montgomery Way,	Odiham Close.

- b) 'No Waiting Monday to Friday 10am-11am and 2pm-3pm (excluding bank holidays)' in the following roads:

Castle Lane,	Conway Close,	Donnington Drive,	Guildford Drive,
Montgomery Way,	Netley Close,	Odiham Close.	

- c) 'No Waiting Monday to Friday 2pm-3pm (excluding bank holidays)' in the following road:

Velmore Road.

The Order has been made with the following modifications to the advertised proposals:

Castle Lane

- i) The proposed extension to the No Waiting at Any Time restriction at its junction with Bournemouth Road has been omitted;
- ii) The proposed No Waiting at Any Time restriction between the borough boundary and 22 Castle Lane on the south side, and 37 Castle Lane on the north side, has been modified to a No Waiting Monday to Friday 10am-11am and 2pm-3pm restriction;

Montgomery Way

- i) The proposed No Waiting at Any Time restriction on Montgomery Way, from a point 10 metres north of its junction with Donnington Drive northwards, has been modified to a No Waiting Monday to Friday 10am-11am and 2pm-3pm restriction;

Velmore Road

- ii) The No Waiting restriction in Velmore Road has been made with the proposed morning no waiting period omitted;

The Order will come into operation on 31 May 2016. A copy of the Order may be inspected at my office at the Eastleigh House, Upper Market Street, Eastleigh during normal office hours or on the Councils website: www.eastleigh.gov.uk/TRO

Any persons wishing to question the validity of this Order or any provisions contained in it on the grounds that any requirement of the Act, or any instrument made under that Act has not been complied with in relation to the Order, may within six weeks from 26 May 2016 apply to the High Court for this purpose.
