

THE BOROUGH OF EASTLEIGH (CHANDLER'S FORD AND  
HILTINGBURY) (AMENDMENT NO \*\*) ORDER 201\*

The Council of the Borough of Eastleigh (hereinafter referred to as "the Council") pursuant to arrangements made under Section 19 of the Local Government Act 2000 with the Hampshire County Council in exercise of the powers of the said County Council under Sections 1, 2 and 4 of the Road Traffic Regulation Act 1984 ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

Commencement and Citation

1. This Order shall come into operation on xxxxxxxxxxxx and may be cited as the "Borough of Eastleigh (Chandler's Ford and Hiltingbury) (Amendment No \*\*) Order 201\*\*".

Prohibition and Restriction of Waiting

2. In this Order the Principal Order means The Borough of Eastleigh (Chandler's Ford and Hiltingbury) Consolidation Order 2016

3. The Principal Order is hereby amended as follows:

4. In Article 2(1) of 'Part 1 – General' the following shall be inserted after the definition for 'civil enforcement officer'

"controlled zone" shall mean those roads and lengths of roads indicated in Schedule 4.1 and Schedule 4.2 to this Order;

5. In Article 2(1) of 'Part 1 – General' the following shall be inserted after the definition for 'invalid carriage'

"loading bay" means an area on the highway designated and described as a loading bay by Article 20A and is contained in Schedule 2.1

6. In Article 20 the following shall be inserted:

(h) between the hours of 10am and 11am and between the hours of 2pm and 3pm on any day other than a Sunday on the sides of roads or lengths of roads specified in Schedule 1.7 to this Order

(i) between the hours of 10am and 11am and between the hours of 2pm and 3pm on any day other than a Saturday or Sunday or a bank holiday on the sides of roads or lengths of roads specified in Schedule 1.8 to this Order

(j) between the hours of 10am and 11am and between the hours of 2pm and 3pm on any day other than a Saturday or Sunday or a bank holiday on the sides of roads or lengths of roads specified in Schedule 4.1 to this Order

(k) Between the hours of 2pm and 3pm on any day other than a Saturday or Sunday or a bank holiday on the sides of roads or lengths of roads specified in Schedule 4.2 to this Order

7. After Article 20 there shall be inserted the following:

20A (a) Each of the parts of roads specified in Schedule 2.1 to this Order is hereby designated as and is authorised to be used, subject to the provisions of this Order, as a loading bay.

(b) Save as provided in Article 22 of this Order no person shall except upon the direction or with permission of a Police Constable in uniform or a Civil enforcement officer cause or permit any vehicle to wait in the loading bays specified in Schedule 2.1 to this Order on any day and at any time unless loading or unloading is taking place.

8. Article 21(b) shall be revoked and replaced with the following:

(b) if a period of less than 4 hours has elapsed since the termination during the said hours of the last period of waiting (if any) of the vehicle on any of those sides of roads or in those lengths of roads within the same road.

9. After Article 21 there shall be inserted the following:

21A. Save as provided in Articles 22 and 24 of this Order no person shall except upon the direction or with permission of a Police constable in uniform or a Civil Enforcement officer cause or permit any vehicle to wait between the hours of 9.30am and 9.30am and 3.30pm and 4.30pm on any day other than a Saturday or Sunday on the side of road or in the lengths of roads specified in Schedule 3.1 to this order –

a) For a longer period than 15 minutes; or

b) If a period of less than 30 minutes has elapsed since the termination during the said hours of the last period of waiting (if any) of the vehicle on those sides of roads or in those lengths of roads.

10. In Article 22 the text ‘*and 20A and 21A*’ shall be inserted after the text ‘Nothing in Article 20 and 21’

11. In the First Schedule (No Waiting at Any Time) after item number 8 relating to Beech Road there shall be inserted:

8a	Beresford Gardens	Both	From its junction with Beresford Road in a westerly direction for a distance of 14 metres.
8b	Beresford Road	West	From a point 15 metres south of its junction with Beresford Gardens in a northerly direction to a point 15 metres north of that junction.
8c	Beresford Road	East	From a point 12 metres south of its junction with Westmorland Way in a northerly direction to a point 21 metres north of that

junction.

12. In the First Schedule (No Waiting at Any Time) after item number 12 relating to Bodycoats Road there shall be inserted

19. In the First Schedule (No Waiting At Any Time) after item number 71 relating to Electron Way (east spur) there shall be inserted:

71a Fir Croft Drive Both From its junction with Bodycoats Road in a  
northerly direction for a distance of 24.5  
metres.

20. In the First Schedule (No Waiting At Any Time) after item number 84 relating to Heathcote Road there shall be inserted:

84a Heathlands Both From its junction with Valley Road in a

metres, to include the school access.

easterly and south westerly direction for a  
distance of 42 metres.

23. In the First Schedule (No waiting at any time) after item number 159 relating to Merdon Avenue there shall be inserted:

159a Montgomery Both From a point 16 metres west of its junction  
Way with Odiham Close in a north eastern  
direction to a point 10 metres north of its  
junction with Donnington Drive.
