Contact details will be passed onto the Planning Inspector so they can contact you regarding the examination in public process. Comments should clearly state the document and policy or paragraph that your comments relate to. It is recommended that you include a summary of your comments and set out any changes you consider necessary to address any concerns raised.

The Council will produce a summary of who responded to the consultation and the main issues raised and will submit this with all the representations to the Secretary of State. At the examination in public, the Planning Inspector will consider whether the Local Plan meets the legal and process requirements for a Local Plan including the Duty to Co-operate and if it is 'sound'.
