**THE BOROUGH OF EASTLEIGH (HEDGE END, WEST END, & BOTLEY)**

**(AMENDMENT NO 4) ORDER 2018)**

Eastleigh Borough Council (hereinafter referred to as "the Council") pursuant to arrangements made with the Hampshire County Council in exercise of the powers of the said County Council under Sections 1, 2 and 4 of the Road Traffic Regulation Act 1984 ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

**Commencement and Citation**

1. This Order shall come into operation on 01 December 2018 and may be cited as the "The Borough of Eastleigh (Hedge End West End and Botley) (Amendment No 4) Order 2018."

**Prohibition and Restriction of Waiting**

2. In this Order the Principal Order means The Borough of Eastleigh (Hedge End West End and Botley) Consolidation Order 2015.

3. The Principal Order is hereby amended as follows:

- (a) In the First Schedule (No Waiting at Any Time) after item number 51 (relating to Malvern Gardens) there shall be inserted:

- (b) In the First Schedule (No Waiting at Any Time) after item number 419 (relating to Stroudley Way (roundabout)) there shall be inserted:

(c) In the first Schedule (No Waiting at Any Time) after item number 133 (relating to Freegrounds School's Service Road) there shall be inserted:

133a. Freegrounds North From a point adjacent to the righthand side of the  
Ave. driveway access of No17 Freegrounds Avenue in a  
north westerly direction for a distance of 13 metres.

133b. Freegrounds Both From the junction of Freegrounds Avenue and  
Ave. / Sherbourne Sherbourne Way into Sherbourne Way for a distance  
Way of 10.5 metres.

(d) In the First Schedule (No Waiting at Any Time) after item number 240 (relating to Kings Copse Road) there shall be inserted:

240a. Kings Copse South From the junction of Kings Copse Road and  
Road. Havendale in an easterly direction for a distance of 24  
Junction with metres.

(e) In the First Schedule (No Waiting at Any Time) after item number 276 (relating to Mapleton Road) there shall be inserted:

276a. Mapleton North From a point adjacent to the start of the radii kerb at  
Road the front of No 4 Mapleton Road to a point adjacent to  
the end of the radii kerb at the side of No 4 Mapleton  
road a distance of 20 metres.

(f) In the First Schedule (No Waiting at Any Time) after item number 28 (relating to Beech Road) there shall be inserted:

28a. Beechwood North From the junction of Beechwood Rise and Chalk Hill in  
Rise an easterly direction for a distance of 24 metres.
