(AMENDMENT NO. 7) (PART 1) ORDER 2019

The Council of the Borough of Eastleigh (hereinafter referred to as "the Council") pursuant to arrangements made with the Hampshire County Council in exercise of the powers of the said County Council under Sections 1, 2 and 4 of the Road Traffic Regulation Act 1984 ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

Commencement and Citation

1. This Order shall come into operation on 3 August 2020 and may be cited as the "The Borough of Eastleigh (Hedge End, West End and Botley) (Amendment No.7) (Part 1) Order 2019."

Prohibition and Restriction of Waiting

2. In this Order the Principal Order means The Borough of Eastleigh (Hedge End, West End and Botley) Consolidation Order 2015 as amended.
3. The contents of Schedule 1 to this Order shall be deleted from Schedule 1 to the Principal Order.
4. The contents of Schedule 2 to this Order shall be added to Schedule 1 to the Principal Order.
