**(AMENDMENT NO. 8) ORDER 2020**

The Council of the Borough of Eastleigh (hereinafter referred to as "the Council") pursuant to arrangements made with the Hampshire County Council in exercise of the powers of the said County Council under Sections 1, 2 and 4 of the Road Traffic Regulation Act 1984 ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

**Commencement and Citation**

1. This Order shall come into operation on 3 August 2020 and may be cited as the "The Borough of Eastleigh (Hedge End, West End and Botley) (Amendment No. 8) Order 2020."

**Revocation**

2. The Borough of Eastleigh (Upper St Helens Road, Hedge End) Experimental Order 2018 shall be revoked in its entirety

**Interpretation**

3. Any reference in this Order to an Act, Statutory Instrument, Regulation or Order shall be construed as a reference to that Article or Schedule in this Order.
4. In this Order, the Principal Order means The Borough of Eastleigh (Hedge End, West End and Botley) Consolidation Order 2015 as amended.

**Prohibition and Restriction of Waiting**

5. The contents of Schedule 1 shall be added to Schedule 1 to the Principal Order
6. The contents of Schedule 2 shall be deleted from Schedule 1 to the Principal Order

**Schedule 1 – No waiting at any time (addition)**

	Road	Side	Description
168b	Heath House Close	Both	From its junction with Heath House Lane southwards for 15 metres
168a	Heath House Lane	South	From a point 6 metres east of Heath House Close westwards to the boundary of "Tremar" and 2 Fredricks Cottages
414a	Stockholm Drive	North-east	From its junction with Upper St Helens Road south-eastwards for 10 metres
414b	Stockholm Drive	South-west	From its junction with Upper St Helens Road south-eastwards for 16 metres
464	Upper St Helens Road	West and North-west	From its junction with Heath House Lane northwards and north-eastwards to a point 5 metres north-east of the property boundary of Nos 47b and 49
465a	Upper St Helens Road	South-east	From a point 15 metres south-west of its junction with Stockholm Drive north-eastwards to a point 23 metres north-east of that junction.

**Schedule 2 – No waiting at any time (deletion)**

	Road	Side	Description
464	Upper St Helens Road	West	From its junction with Heath House Lane in a northerly direction for a distance of 44.5 metres.
465a	Upper St Helens Road	North-west	From a point 83 metres south-west of its junction with Lyons Place in a north easterly direction to a point 16.5 metres north east of that junction.
