(AMENDMENT NO 7) ORDER 2020

The Council of the Borough of Eastleigh (hereinafter referred to as "the Council") pursuant to arrangements made with the Hampshire County Council in exercise of the powers of the said County Council under Sections 1, 2 and 4 of the Road Traffic Regulation Act 1984 ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

Commencement and Citation

1. This Order shall come into operation on 10 August 2020 and may be cited as the "The Borough of Eastleigh (Chandler's Ford and Hiltingbury) (Amendment No 7) Order 2020".
2. Except where otherwise stated, any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.
3. Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.
4. In this Order the Principal Order means The Borough of Eastleigh (Chandlers Ford and Hiltingbury) Consolidation Order 2016, as amended.

Prohibition and Restriction of Waiting

5. The contents of Schedule 1 shall be added to Schedule 1 to the Principal Order
6. The contents of Schedule 2 shall be added to Schedule 6 to the Principal Order

	Road	Side	Description
103a	Hiltingbury Road	North-east	From its junction with Kingsway south-eastwards for 20 metres
103b	Hiltingbury Road	South-west	From its junction with Kingsway south-eastwards for 58 metres
184a	Peeverells Wood Avenue	North-east	From its junction with Winchester Road south-eastwards to a point 38 metres south-east of the boundary of Nos 1 & 3

Schedule 2 Prohibition of verge parking (addition)

	Road	Side	Description
4a	Hiltingbury Road	South-west	From a point 19 metres north-west of its junction with Malibres Road to a point 58 metres south-east of its junction with Kingsway
4b	Hiltingbury Road	North-east	From a point 19 metres north-west of its junction with Malibres Road to a point 20 metres south-east of its junction with Kingsway
