

General issues

Action A Produce updated schedule of proposed main modifications.

1. The Council is producing the following documents showing the main modifications proposed:
 - Schedule of main modifications for consultation;
 - Schedule of additional minor modifications not affecting soundness (for information); and
 - Document of proposed changes to the Policy Maps.
2. These documents will be available at www.eastleigh.gov.uk/localplan.

Action B Update the SA to reflect A

3. The SA will be updated to assess the main modifications changes.

Action C Add glossary.

4. A glossary is added in the Local Plan after Appendix C (MM123). Modifications have also been made to add in reference to the glossary as required throughout the plan.

Action D General – make it clear where supporting text for each policy starts and ends; and the difference between the introduction to a section and the supporting text to a policy

5. The final Local Plan document follows a standard format for policies:
 - i. Section title;
 - ii. Introduction to section;
 - a. Relevant Issues and Objectives
 - b. Related strategies/policies
 - c. Introductory text (context only not explanation of the policy)
 - iii. Policy text;
 - iv. (For site allocations) Site map;
 - v. Supporting text
6. The track change Local Plan sets out how the text in the final document will change. The final document will also be typeset and use sub-headings and text formatting to provide further clarity.

Action E Ensure consistent approach to policy criteria numbering

7. Policy criteria numbering will follow a consistent approach to bullets and numbering; number (i.e. 1), letter (a) and Roman numeral (i).

Action F Ensure illustrative inset maps are included in the plan document for all site allocations

8. The Council will publish revised inset maps. This includes changes to maps in the submission Local Plan as well as additional maps not included the submission plan. This draws on the inset maps published before the hearing sessions in ED35.
9. The proposed main modifications schedule includes new and amended inset maps for the following sites in the Submission Local Plan, June 2018 (nb. policies will be renumbered to reflect changes to site policies including completed sites and sites formerly included in policy DM25):
 - i. Employment sites; E6, E7, HE4, WE1 and WE2 (all as shown in ED35), CF2 (to be renumbered CF4), E1 and E9 (amend maps in ED35) and WE3 (not previously published as an inset map);
 - ii. Gypsy and Traveller sites; BU4 and BU5 (as shown in ED35);
 - iii. New residential sites (formerly listed in DM25); new policies CF1 Land at Common Road Industrial Estate, Chandlers Ford; CF2 Land to the rear of 75-99 Hiltingbury Road; and E2 Land at Toynbee Road, Eastleigh;
 - iv. Strategic site HH1, heritage sites BU9 (to be renumbered BU7, amend map in ED35) and BO7 (not previously published as an inset map); other sites Bi1, HA1, HA3, CF1 (to be renumbered CF3), BU7 (to be renumbered BU6), (all as shown in ED35), HA2 and E3 (amend maps in ED35), E4, E12 (to be renumbered E10) and WE4 (not previously published as an inset map);
 - v. District centre maps – Hedge End, Fryern District Centre (as shown in ED35)
10. Please note that the following site policies will no longer be included in the final document (nb. site policies as set out in the Submission Local Plan, June 2018):
 - i. Residential sites completed or substantially built out; DM24, DM25 (except b, c and d), FO2, FO5, FO6 and E2;
 - ii. Employment sites under construction or no longer available; FO8 and CF3;
 - iii. Other sites; FO6 (now part of HH1), FO7, BU6 (travelling communities pitches with planning permission), BU8 (open space not taken forward), HO1, E10, E11 (completed new open space) and HE7 (cemetery site not taken forward).
