

THE BOROUGH OF EASTLEIGH (EASTLEIGH TOWN CENTRE) (AMENDMENT NO 11)
ORDER 2020

The Council of the Borough of Eastleigh (hereinafter referred to as "the Council") pursuant to arrangements made with the Hampshire County Council in exercise of the powers of the said County Council under Sections 1, 2 and 4 of the Road Traffic Regulation Act 1984 ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

Commencement and Citation

1. This Order shall come into operation on 15 March 2021 and may be cited as the "The Borough of Eastleigh (Eastleigh) (Amendment No 11) Order 2020."

Prohibition and Restriction of Waiting

2. In this Order the Principal Order means The Borough of Eastleigh (Eastleigh Town Centre) Consolidation Order 2013 as amended.
3. The contents of Schedule 1 shall be inserted into Schedule 1 to the Principal Order.
4. The contents of Schedule 2 shall be deleted from Schedule 1 to to the Principal Order.
5. The contents of Schedule 3 shall be inserted into Schedule 1.5 to the Principal Order
6. The contents of Schedule 4 shall be deleted from Schedule 1.4 to the Principal Order
7. The contents of Schedule 5 shall be deleted from Schedule 2.1 to the Principal Order
